

On 1 March, NPC Wales launched its Pensioners' Manifesto for the upcoming Senedd elections.

The manifesto was developed using the issues that members have told us are important to them, including health and social care, fuel poverty, TV licences, universal pensioner benefits, public transport and older people's rights. It has been sent to all Members of the Senedd, the main parties in Wales, local council leaders and all candidates standing in the elections.

We hope that it will attract attention to the policies and practices that will make life better for older people in Wales.

TV licence

NPC UK has written to the new Chair of the BBC Board regarding the BBC TV licence.

On 2 February Richard Sharp, Chairman of the BBC Board confirmed that he does not favour a subscription model for the BBC.

The TV licence will increase to £159 per year from April. The licence fee is set by the government following negotiations with the BBC.

NPC's position remains: "As you will be aware, the older generation are the largest audience the BBC has and

we are still campaigning for the government to take back responsibility for the full funding of the free TV licence for over 75s. We strongly believe that it is the government who are responsible for funding social welfare not your broadcasting corporation. We hope you agree and that there is a force for change in your forthcoming negotiations."

The Government is not going ahead with plans to decriminalise non-payment of the licence fee but will keep the issue under 'active consideration'. Culture Secretary Oliver Dowden

said switching to a civil enforcement system risked being seen as an 'invitation' to evade the fee and could ultimately reward those who declined to pay. Approximately 750,000 over 75s have so far refused to pay.

NPC UK has also written a rebuttal letter to the Daily Mail. A letter in the Daily Mail mentioned Jan Shortt and NPC UK and commented that the increase in licence fees was affordable so why complain? The Daily Mail, with the avid support of the Tax Payers Alliance, is strongly anti-BBC.

Post Office Card Account

NPC Wales recently brought a new issue to the attention of the Cross Party Working Group on Ageing.

The Westminster
Government Minister for
Works and Pensions has
decided not to renew the
contract between the
Department for Work and
Pensions (DWP) and Post
Office Ltd for the Post
Office Card Account (POCA)
after November 2021. The
POCA is used by many
older people to receive their
pensions.

DWP is writing to card holders requesting that they supply alternative bank account or building society account details to receive payment of their state pension going forward. All major high street banks are obliged to provide a basic, fee-free, no overdraft facility bank account when one is requested with no credit checks required. Alternatively, the Post Office has an Instant Savings Account, which can be opened online or in branch.

If alternate account details are not received, there is an Exceptional Service Payment option available for payment of pensions and benefits. This involves a payment card and a voucher code that is sent via email or text.

NPC Wales feels that this is another example of discrimination against older people, particularly in Wales where we have a large older population and poor transport links. It is part of the downside of moving to a cashless society and an overreliance on the finance industry and banks – they are closing branches in both rural and urban areas so they cannot fill the void. Pay Points and ATMs are also disappearing fast.

Digital Inclusion / Exclusion Campaign

One in ten people in Wales are not online; this can mean missing out financially, socially and in accessing services and information. NPC Wales launched our Connections For All/Cysylltiadau i Bawb campaign on 1 February. We are joining NPC UK in calling for an end to digital poverty and we will be running a series of events around this topic over the next year.

Our first event as part of the Connections For All/ Cysylltiadau i Bawb campaign was a webinar called Safer Connections on Safer Internet Day. With more older people isolating at home and apart from friends, family and support networks, their need to use the internet safely has never been greater. Much good is already happening in Wales, but more can be done to overcome the barriers that discourage older people from embracing the online world.
